Dispose of your expired and unneeded prescription and over the counter drugs safely and securely.

Please note Controlled Substances (prescription narcotics, sleeping pills, pain relievers stimulants and behavioral drugs) can only be accepted at #1 the Alameda County Sheriff's department site in San Leandro.

How to Package:

Protect your privacy and help us save money

Pour all your pills out into a ziploc bag.

Recycle the empty pill bottles in your recycling cart.

For liquids and creams:

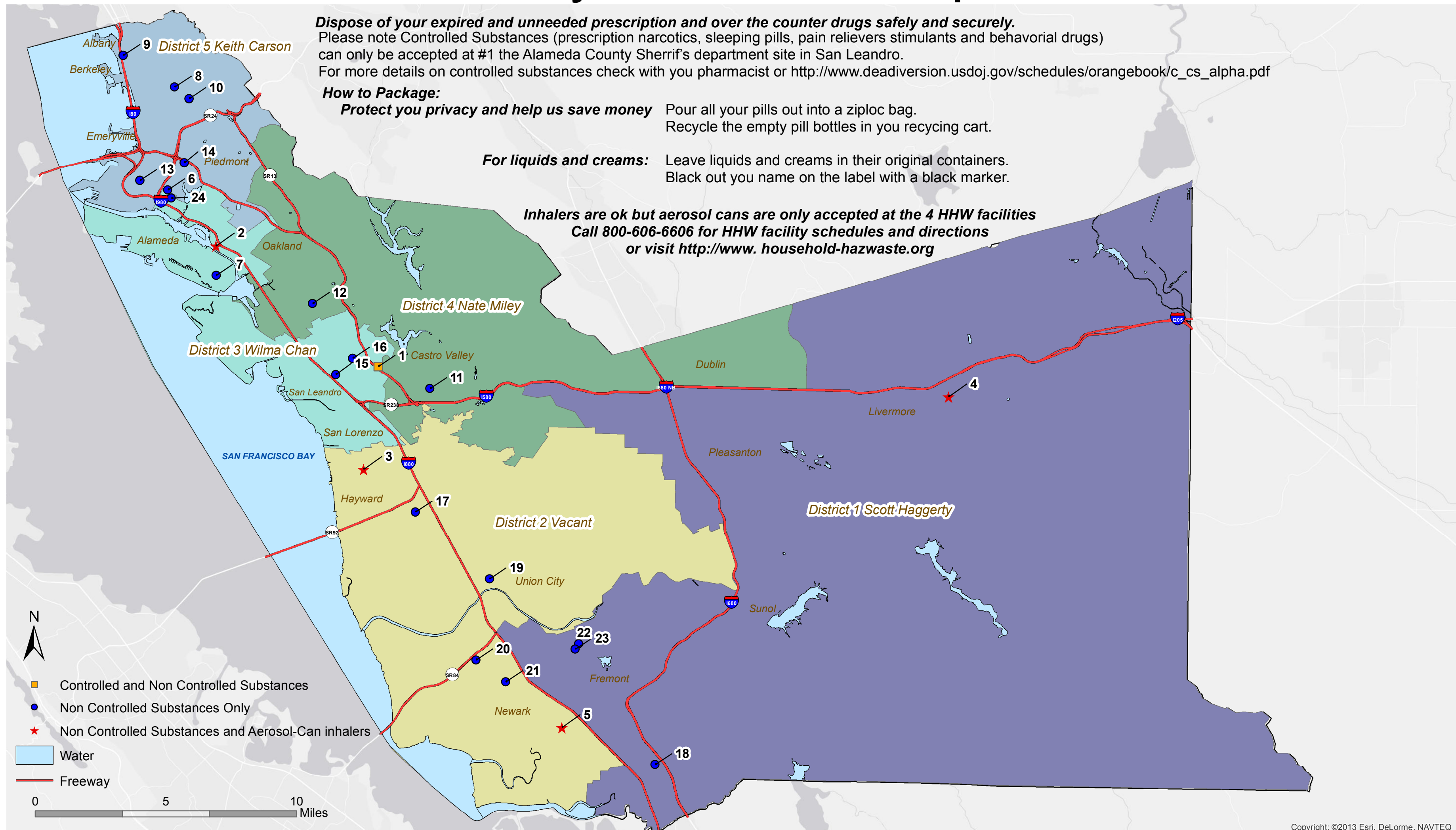
Leave liquids and creams in their original containers.
