The Alameda County Department of Environmental Health, Office of Solid/Medical Waste Management, Local Enforcement Agency (LEA) for the Department of Resources, Recycling, and Recovery (CalRecycle), has received an application for a Revised Solid Waste Facility Permit (SWFP) for the increase in solid waste facility boundary and to clarify operational changes. The LEA has determined that the proposed change is a significant change as defined in §21563(d)(6) and requires a revised solid waste facilities permit. The application was deemed complete and correct and acceptable for filing on July 10, 2019. This informational meeting (in compliance with Public Resources Code Section 44004) is for all interested parties to ask questions and provide comments on the proposed Revised SWFP. Comments may be submitted prior to the meeting, directly to Wing Suen by postal mail, email, or fax. The meeting is strictly informational, and no official decision will be made at the meeting regarding the formal determination on the SWFP application.

## **Permit Description:**

The Project Applicant, Livermore Sanitation, Inc. (LSI), currently operates a solid waste transfer and recycling facility on a 4.29-acre parcel (APN 099B-5752-18-1) at 7000 National Drive in the City of Livermore. The owner of the land and the facility is Livermore Sanitation, Inc. (LSI).

LSI submitted a Revised SFWP to address the following operational changes:

- Propose to increase the facility size from 4.29 acres to 4.86 acres to include an additional 0.57-acre parcel. The 0.57-acre parcel will be used for storage of empty disposal bins, containers or facility supplies that are not related to solid waste activities.
- Propose to increase the solid waste facility boundary line from 1.02 acres to 4.29 acres to encompass
  the previously existing solid waste vehicles maintenance building and the solid waste vehicles and
  equipment parking area.
- Update the Transfer/Processing Report (TPR) to clarify operational activities and current environmental permits.

## Purpose of the Meeting:

This Public Informational Meeting is for any interested parties to learn more about the proposed permit and to provide comments to the LEA regarding the proposed action. The decision to issue or not to issue the Revised SWFP must be made by the LEA within 120 days of the date the application was deemed complete as required by Statute. Prior to the issuance of the SWFP, the LEA must request and receive concurrence from the Department of Resources Recycling and Recovery (CalRecycle). If you wish to be notified of the CalRecycle meeting, please notify the LEA in writing no later than August 23, 2019.
