Introduction

Please be advised that the Alameda County Department of Environmental Health, Office of Solid/Medical Waste Management, the Local Enforcement Agency (LEA) for CalRecycle received and approved a Report of Facility Information (RFI) Amendment for Altamont Landfill and Resource Recovery Facility (ALRRF)'s Solid Waste Facility Permit (SWFP). The LEA is certified by CalRecycle to enforce state laws and regulations at solid waste facilities within Alameda County.

Description of project and LEA's determination

The Project Applicant, Waste Management of Alameda County, Inc. (WMAC) currently operates a solid waste facility on 2,170 permitted acres area allowing 472 acres for disposal. This facility is located at 10840 Altamont Pass Road, Livermore, CA 94551. On July 9, 2015, the LEA received from WMAC's ALRRF, a SWFP Application package to amend the RFI requesting to update the document to:

Include Section 7.6.1 of the Joint Technical Document (JTD) - **Green Material and C&D Wood Debris Recycling** by a third-party green and C&D wood debris processing and grinding operation at the facility.

- a) Description of processing of green materials and C&D wood debris recycling by a third party operators;
- b) Description of locations of green materials and C&D wood debris stockpiles;
- c) Submittal of revised Site Plan – Greenwaste and C&D wood debris stockpiles location;
- d) Description that the Chipping and Grinding Operation includes the following information:
 - i) The quantity of incoming green and C&D wood debris materials will be under 200 tons per day;
 - ii) Unprocessed C&D wood materials will not remain on site for more than 30 days.

No other changes to the SWFP are under consideration at this time. The LEA finds that the proposed changes are consistent with the CalRecycle State Minimum Standards, and is consistent with all applicable certified and/or adopted California Environmental Quality Act (CEQA) documents. The proposed changes do not conflict with the terms and conditions in the current SWFP. The LEA approved the amendment on August 8, 2015.
