Alameda County Department of Environmental Health, Office of Solid/Medical Waste Management, Local Enforcement Agency (LEA) for the Department of Resources, Recycling, and Recovery (CalRecycle), has received an application for a Revised Solid Waste Facility Permit (SWFP) for Vasco Road Landfill (VRL) located at 4001 North Vasco Road, Livermore. The application was deemed complete and correct and acceptable for filing on September 20, 2018. This informational meeting (in compliance with Public Resources Code Section 44004) is for all interested parties to ask questions and provide comments on the proposed Revised SWFP for VRL. Comments may be submitted prior to the meeting, directly to Tina-Baohuong Tran by postal mail, email, or fax. The meeting is strictly informational, and no official decision will be made at the meeting regarding the formal determination on the SWFP application.

Existing Permit/Conditions:

As a result of the Five-Year Permit Review, Republic Services Vasco Road, LLC submitted a Revised SWFP for the existing Vasco Road Landfill. VRL is currently permitted to accept and process 2,518 Tons Per Day (TPD) of waste materials that include municipal solid waste (MSW), clean soils, treated wood waste, curbside food and green waste, public green waste, construction and demolition, dry wall, residential debris, appliances/white goods, mattresses and box springs, non-friable asbestos, ash and refractory materials, industrial waste, sewage sludge, plastics, paper, metals, glass, cardboard, treated auto shredder waste, and waste tires. Current days and hours of operation are from Monday through Friday from 6:00 am to 5:00 pm; Saturday from 6:00 am to 4:30 pm; Sunday through special arrangement for commercial haulers only. VRL is closed on Christmas Day, Easter Sunday, Thanksgiving, and New Year's Day. The operating area of the solid waste facility boundary encompasses 323 acres with three (3) parcels: Parcel 1: 99B-4901-2-13, 99B-4901-6-5, 99B-4926-1-1, and 99B-4926-3-3; Parcel 2: 99B-4926-1-2, 99B-4926-2-5, and 99B-4926-2-6, and 902-6-2-2; and Parcel 3: 99B-4901-2-14 and 99B-4926-2-10.

Proposed Change(s) to the Permit:

There will be no change in the Maximum Permitted Tonnage and Maximum Traffic Volume at VRL. The proposed revised permit is to allow the following change:

- 1. Change in the Days and Hours of Operation: Closed after 2:30 p.m. on Christmas Eve and New Year's Eve;
- 2. Update the following to reflect the current and proposed design and operational changes at the facility:
 - a. Site Plan;
 - b. Equipment and Personnel lists;
 - c. Process, Transfer and Recycling activities (food waste, green waste and construction and demolition materials);
 - d. Various appendices to reflect current operations and procedures;
 - e. Non-Water Quality Corrective Action Plan and Cost Estimate;
 - f. Remaining site capacity and site life information;
 - g. Information on current and planned landfill phasing;
 - h. Implementation/construction of the third stage Partial Final Closure, which is approximately fifteen (15) acres;
 - i. Environmental control systems (text and figures);
 - j. Parts E and F of the Joint Technical Document (JTD) Preliminary Closure and Post-Closure Maintenance Plan (PCPCMP).

Purpose of the Meeting:

This Public Informational Meeting is for any interested parties to learn more about the proposed permit and to provide comments to the LEA regarding the proposed action. The decision to issue or not to issue the Revised SWFP must be made by the LEA within 120 days of the date the application was deemed complete as required by Statute. Prior to the issuance of the SWFP, the LEA must request and receive concurrence from the Department of Resources Recycling and Recovery (CalRecycle). If you wish to be notified of the CalRecycle meeting, please notify the LEA in writing no later than November 5, 2018.
