REQUEST TO REMOVE HOMEOWNERS' EXEMPTION

If the homeowners' exemption is granted and the property later becomes ineligible for the exemption, you are responsible for notifying the Assessor of the act immediately. Failure to notify the Assessor by December 10th of the year in which the claim would apply will subject you to repayment of the exemption amount plus a penalty on the escaped assessment pursuant to California Revenue and Taxation Code Section 531.6.
