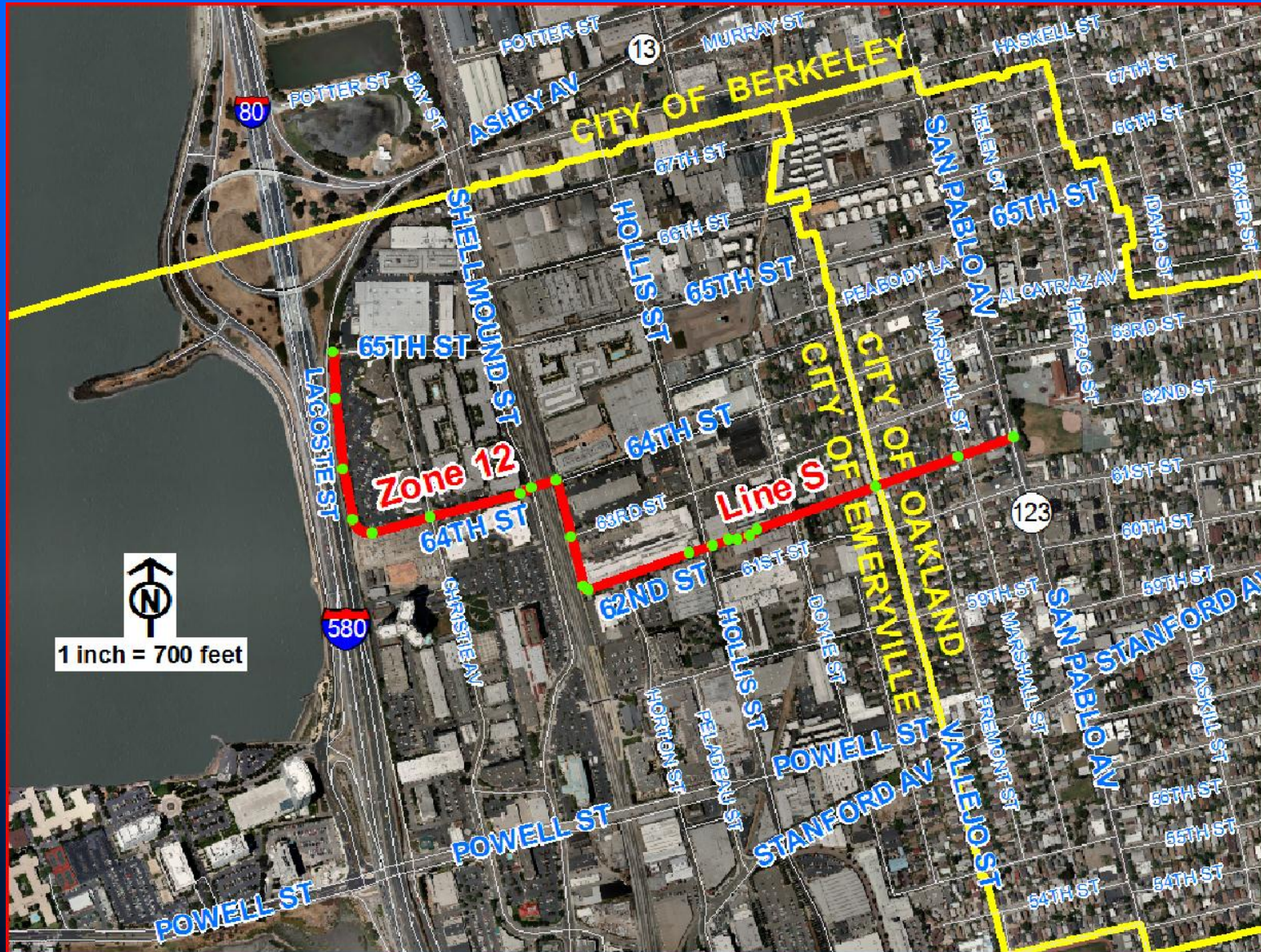

Benefit of the Project

- Minimize flooding problem on San Pablo Avenue and 61st Street in Oakland
- Minimize the potential for storm water sheet flowing from above San Pablo Avenue along 62nd Street
- Relieve the capacity of the existing storm drain line along San Pablo Avenue by diverting portion of the flows to the new by-pass storm drainage line along 62nd Street
- Minimize flooding problem in the vicinity of 62nd Street and Overland Avenue in Emeryville
- Improve overall storm water conveyance to the Bay

Construction Schedule

- Start date: Monday, **October 24, 2011**
- Construction Hours: 8:00AM to 5:PM
Mondays thru Fridays. No work on weekends or holidays
- Estimated Duration: Seven Weeks, weather permitting

What to Expect during Construction?

- Storm drain pipes installation along north side of 62nd street by the curb and gutter.
- Parking on both sides of 62nd Street between Vallejo St and San Pablo Avenue will be restricted during construction hours. Parking is allowed on all adjacent streets during construction hours.
- Driveway access during construction hours may be temporarily restricted due to open trenching. Access during non-construction hours will be maintained at all times.
- Local traffic will be maintained.
- Temporary storage of pipes and equipment on the road side.
